लोक निर्माण विभाग उत्तराखण्ड में संविदा पर विधि परामर्शी की नियुक्ति हेतु

महामहिम राज्यपाल महोदय, उत्तराखण्ड की ओर से लो0नि0वि0, उत्तराखण्ड द्वारा विभागीय एवं अनुबन्धित कार्यों हेतु विभिन्न न्यायालयों में चल रहे वादों पर विशेषज्ञ/विवेचना/विधिक राय हेतु आउटसोर्स के माध्यम से 01 वर्ष हेतु संविदा पर तीन विधि परामर्शी नियुक्त किये जाने हेतु विधि विषय में स्नातक अभ्यर्थियों से Expression of Interest आमंत्रित किये जाते हैं। अभ्यर्थी का न्यूनतम विधि स्नातक होना अनिवार्य है। विधि विषय में स्नातकोत्तर उपाधि प्राप्त अभ्यर्थियों को वरीयता दी जाएगी। अभ्यर्थियों को विभागीय एवं अनुबन्धित कार्यों/वादों/आर्बीट्रेशन से सम्बन्धित न्यूनतम 10 वर्ष का अनुभव होना अनिवार्य है, अभ्यर्थी को भारत सरकार/राज्य सरकार के विभागों/संगठनों/स्वायत संस्थाओं/संवैधानिक संस्थाओं में विधिक राय से सम्बन्धित अनुभव होना भी अनिवार्य है। साथ ही सूचना के अधिकार से सम्बन्धित कार्यों का भी अनुभव होना आवश्यक है। चयनित अभ्यर्थियों को संविदा की अवधि के दौरान, तैनाती कार्यालय में उपस्थित रहना अनिवार्य होगा एवं आवश्यकतानुसार सर्वोच्च न्यायालय, नई दिल्ली, उत्तराखण्ड उच्च न्यायालय नैनीताल, सचिवालय उत्तराखण्ड, उत्तराखण्ड सूचना आयोग देहरादून, उत्तराखण्ड लोक सेवा अधिकरण एस0सी0आयोग/एस0टी0 आयोग, मानवाधिकार आयोग एवं अन्य राजकीय कार्यालयों में भी राजकीय कार्यों के सम्पादन हेतु समय समय पर जाना होगा।

An Expression of Interest (EOI) is hereby invited on behalf of the Honourable Governor of Uttarakhand, by the Public Works Department, Uttarakhand from the persons graduated in Law for engagement as Legal Advisor on contract basis through outsource for one year to provide expert and specialized services on legal matters and arbitration cases related to the Department. The total number of vacancies for the above mentioned post is three. The basic qualification required for the above post is LLB. However, the candidates having LLM and higher qualification shall be preferred. The interested candidates should also have a minimum of 10 years of working experience in handling matters related to departmental contractual works/ court cases/ arbitration cases and should have a sound knowledge and experience of working and advising Departments of Govt. of India/State Govt./ Organizations/Autonomous Bodies/ Statutory Bodies. He should also have experience on matters related to Right to Information Act.

The selected candidates will be required to be present at the place of posting and will be required to visit the Supreme Court of India, New Delhi/ High Court of Uttarakhand, Nainital/ the Secretariat of Uttarakhand/ Uttarakhand Information Commission Dehradun/ Uttarakhand Public Service Tribunal/ Humans Rights Commission/SC Commission /ST Commission and other Govt. offices for govt. works as and when required. The initial contract for the above posts shall be for one year which will be extendable on mutual agreement and requirement basis. A consolidated amount of Rs 70,000.00 per month will be payable to the Legal Advisors by the Department.

## Terms Of Reference

### 1-Scope of Services

The Legal Advisor would be responsible for the following activities (The "service") :--

- (a) Assisting PWD by providing legal advice in different Court Cases/ arbitration cases/ service matters/other legal matters.
- (b) The Legal Advisor will have to prepare within time bound period all the related legal document such as written statement/counter affidavit etc. related to cases of different Courts/ Public Service Tribunal/Arbitral Tribunal/Commissions and also will have to draft correspondence to different Organizations/ Institutions/offices,etc.
- (c) The legal Advisor will have to follow all the rules & regulations of PWD, Govt. of Uttarakhand.

### 2- Terms of Service

Terms of services are set out as below:-

- a) He would be based in the place of posting.
- b) Local conveyance for attending office will not be provided by the PWD.
- c) He will report to the Engineer- in-Chief, PWD,Dehradun or the officer nominated by him for this purpose or the Head of Office of his posting.
- d) He shall not divulge during the continuance of the engagement, except in proper course of duties as legal advisor, any of the affairs or confidential information related to PWD to any other entity, nor use or attempt to use any information which may in any way cause loss to Govt. of Uttarakhand.
- (e) Outstation travel shall be made after written consent of Engineer-in-Chief, PWD, Dehradun or the Head of the Office of his posting. T.A in this regard will be admissible as per rules applicable at time to time.
- (f) Casual Leave shall be admissible as per rules. Weekly and Govt.Holidays shall also be admissible. For the absence without sanction of leave, amount on pro-rata basis will be deducted from the payments made to Legal Advisor.



**3- Fees & Terms of Payment.**

- (a) The contract of service shall be for a period of 12 months.
- (b) PWD would make payment of a consolidated amount of Rs. 70,000/- per month towards professional fees.
- (c) The monthly payment will normally be made next month after the end of each month.
- (d) Either party shall have option to terminate the agreement during the Contract period by giving one month notice in writing to the other.
