(A) Introduction:-

(B) Experience:-

- 5. Details of similar works duly awarded by client but not yet started, with amount of work, site location and name of client.

(C) Technical Competency and Manpower with reference to subjected works:-

- 1. Brief details of In-house Technical experts, Designers and plant and machinery available with the agency for execution of new projects of similar nature.
- System of Quality control adopted by the agency in field.
- 3. Brief set up of manpower usually adopted by the agency for execution of similar works.

(D) Average Annual Turnover of the Agency over last five year (F.Y.):-

In case of Govt, departments average annual expenditure on construction works over last five years (F.Y.) shall be treated as annual turnover.

(E) Centage Charges:-

Agency will quote its centage charges to be charged from SIIDCUL on the basic cost of work (excluding contingencies). GST shall be payable to agencies as per extant rules.

(F) Criteria for selection:-

The selection of agencies for shortlisting will be done through an In-house committee of SIIDCUL, which will look into above mentioned parameters and centage charges quoted by the agency. The right to reject or shortlist any or all of the applicant agencies is reserved with the committee and its decision shall be final and binding on all applicants.
