The approval of the aforementioned laboratories is subject to following conditions -

- 1. There should be a continued renewal of validity of NABL accreditation.
- 2. This approval has been accorded on the condition that the Laboratory shall maintain quality and integrity of service intact. In case, any negative feedback and deterioration in quality of lab setup is found, this approval will stand cancelled automatically.
- 3. The Department wholly reserves the right to revoke/ suspend the approval on the basis of review at any time. Approval can be withdrawn prematurely if the laboratory is found to be engaged in fraudulent practice.
- 4. Above approval does not make the firm eligible for claiming right to take the work done through them which is subjected to their competitive stand amongst other qualifying specialized firm in the field to avail material testing facilities.
- 5. The tests shall be done in conformity with requirements of the relevant BIS/ ISO standards.
- 6. Logo of NABL should be displayed on all testing reports issued by the lab.
- 7. Hard Copies as well as Scanned Copies of reports of all the tests conducted by the laboratories shall be submitted to the concerned PWD divisions as well as to the Executive Engineer, Research Cell, Office of Engineer-in-Chief, PWD Uttarakhand. (E-mail Id: <a href="mailto:repwduk@gmail.com">repwduk@gmail.com</a>)
- 8. Retention of balance material of tested sample is to be done for at least thirty days in case of conforming samples and sixty days for non-conforming samples from date of receipt of test reports by the Department for witness/verification as per the requirements of the Department.
- 9. The field staff shall have the liberty to witness conducting of test on samples in their presence.
- 10. The approval will automatically lapse after the expiry of this period unless got renewed.
- 11. The performance of the firm shall be monitored by field units and submitted to the approving authority before expiry of validity of approval.
- 12. The laboratories outside Uttarakhand shall have to establish an Office/ Collection Centre in Uttarakhand within 60 days of this approval, failing which, the approval shall be cancelled.
- 13. The laboratories outside Uttarakhand shall have to establish their properly functioning Laboratory in Uttarakhand within 180 days of this approval, failing which, the approval shall be cancelled.
