


Attention is invited to the provisions contained in the recently amended General Financial Rules (GFR) 2017 in respect of tender advertisements for procurement of Goods and Services. In this connection, Rule 161 ( i & ii), 183 (ii) and 201(ii) etc. may be referred.

2. These rules have done away with the need for publishing advertisements in Newspapers for procurement of Goods and Services. This has now been replaced by mandatory e-publishing of advertisement on Central Public Procurement Portal (CPPP) at [www.eprocure.gov.in](http://www.eprocure.gov.in), GeM and Ministry/ Department website.

3. As such, all concerned are advised to strictly adhere to the provisions contained in the GFR 2017 regarding publication of advertisements for procurement of Works, Goods and Services. In case it is felt that advertisement is necessary to be published, approval of the Secretary RTH shall be obtained prior to its publication in Newspaper. In such cases too, advertisement should be published in Newspaper along with publication on CPPP, GeM and website of Ministry/ Department.

4. This supersedes Ministry circular no. RW/NH-11024/3/99-US (D.I) dated 09.03.2000.


