SECTION I

GENERAL INSTRUCTIONS

- 1.1.Uttarakhand Public Works Department (UK PWD) is vested with the responsibility of construction, maintenance and improvement of the vast road network of the state to provide better connectivity and support to all areas of the state. In view of its strategic location of national importance and steep to mountainous terrain, it becomes of utmost importance to provide for high quality road infrastructure which are sustainable and thus provide for overall economic and social growth of the state and nation.
- 1.2 In view of the above, applications on prescribed form for empanelment are invited from reputed consultants /experts having proven expertise, required manpower & necessary experience of preparation of detail project reports for Road works. The empanelled consultants shall be eligible to participate in the tenders to be invited by the UK PWD for preparation of DPRs for Road works under various schemes and sectors of the government. The empanelment will be under two categories as given below;
- Category-R1 --Survey, Geometric Design and Detailed Project preparation for road projects up to 5 km length.
- Category-R2 --Survey, Geometric and pavement design ,Feasibility, Traffic and Transportation Studies, Road Safety Audit and Detailed Project preparation for road projects.
- 1.3The package size, terms of reference etc. will be intimated to consultants at the time of invitation of offers.
- 1.4 The empanelment will be valid for a period of two years, subject to satisfactory and professional performance of the consultant and the year will be reckoned from 1st July to 30th June.
- 1.5The empanelled consulting firms will be required to renew their empanelment at least two months before the completion of two years by applying to H.O.D office P.W.D Dehradun.
- 1.6 Consulting firms interested in empanelment can download the application form from www.pwd.uk.gov.in or can collect the application form from EIC PWD Office, Lok Nirman Bhawan Yamuna Colony, Dehradun.
- 1.7The consultants must indicate the specific category under which their firm wants to be considered for empanelment.

- 1.9Separate application should be submitted for empanelment in separate categories.
- 1.10 The consultants who are already empanelled by the Department before August 2018 are also required to apply for empanelment as per this proforma within two months i.e. 31st October 2018.
- 1.11Applications received will be evaluated by a committee constituted for this purpose. Decision of the committee shall be final and no representation in this regard will be entertained.
- 1.12Application should be submitted duly page numbered and indexed. Applications submitted otherwise will not be considered.
- 1.13 The authority competent to empanel a consulting firm/individual may order cancellation of their empanelment for the reasons to be mentioned in the order and communicated to the firm/individual. Before such an order is passed the consulting firm/individual shall be served with a show cause notice giving reasons for proposed removal and given a reasonable opportunity to explain.
- 1.14 The applicants should submit the empanelment request in the prescribed format with requisite information to:-

SECTION II

INSTRUCTIONS TO APPLICANTS

- 2.1 All information requested for in the enclosed forms should be furnished against the respective columns of the form. If information is furnished in separate documents reference to the same should be given in the respective column. If information is 'NIL' it should also be mentioned as 'NIL'.
- 2.2All the information must be submitted in English. Incomplete and inappropriately filled in application forms will be rejected.
- 2.3The application should be properly bound, indexed and page numbered and strictly following sequence given in the format. Proposals submitted otherwise will not be considered.
- 2.4In case of any change in solvency technical staff, tools and plants or change in partners or constitution of a firm it should be intimated to the authority competent for empanelment.
- 2.5The UK PWD reserves the right to reject any or all applications without assigning any reason. List of empanelled consultants will be placed on website in the public domain.
- 2.6Joint Venture are not allowed.
- 2.7Consulting firms who wish to be considered for empanelment are required to provide the following information:
- (i) Organizational Structure of consultancy firm ANNEXURE-1
- (ii) Experience of the consultants and type of consultancy services undertaken by them during the *last Three years*. This should accompany certificate from the clients of the consultants indicating the type of consultancy services provided and the consultant's overall performance- ANNEXURE-2
- (iii) Brief details of best five DPRs for roads prepared by the consultants.
- (iv)(a) Staff strength of consultancy organization indicating nature of employment of experts (permanent/ temporary/ on contract) together with break-up according to nature of expertise/specialization available with the organization. ANNEXURE-3.
- (b)Details of personnel out of above to be assigned the tasks of field visits and preparation of DPRs
- (v) Type of topographic surveys, soil and material investigation equipment and Page 5 of 16

- instruments available within the firm. Arrangements/tie up with firms having such equipment and instruments may also be indicated in ANNEXURE-4.
- (vi) Financial turnover for <u>last Three Years</u>—ANNEXURE-5
- 2.8Each page of the document should be duly signed by the applicant or his authorized signatory (Attach authorization letter).
- 2.9The applicant shall not be considered for empanelment if the applicant is debarred/blacklisted by any government department/agency at the time of submission of application to PWD, Uttarakhand. The applicant shall submit litigation history/undertaking on non judicial stamp paper of Rs 100/- duly notarized to the effect that the applicant has not been debarred/ blacklisted by any government department/ agency- ANNEXURE 6
- 2.10It may be noted that submission of incorrect/false information about experience and other details etc. may lead to summary rejection of the application and cancellation of empanelment at any stage even after empanelment and action will be taken as found suitable by PWD Uttarakhand- Annexure 7
